Agreement

This letter shall constitute your and my agreement as follows,

1. I hereby engage your services and you accept such engagement to be my manager / agent, though not exclusive, for the term of this agreement. As such, you shall advise counsel me in any and all matters regarding publicity and public relations and the general practices of the modeling, entertainment and advertising industries; advise and counsel me regarding the proper formats for presenting myself to third parties; including aspects of makeup, hair photo composites and formation of a portfolio: and advise and counsel me regarding placements or referrals to secondary agencies in the United States and elsewhere.
2. I hereby appoint you collect and receive monies on my behalf and to retain therefrom all sums due you at any time. I also authorize you to approve and permit the use of my name, photograph, likeness and voice on my behalf and upon my approval. This authorization shall include all self promotion for Creative Management Group, Inc. ie: head sheets, books, electronic media, including but not limited to computer on-line services, the Internet and CD-ROM. I hereby assign to you the proceeds of all assignments done by me, against which, advance payment has been made by you to me. Cancellation fees, expenses, foreign billings, advertising agencies and other clients as determined by your accounting office are paid to artist when payment is received by manager / agent unless other agreements are made prior to assignment. Manager / agent will take all reasonable steps to collect the amounts due with respect thereto.
3. It is acknowledged that the relationship between me as a model, and you as a manager / agent, is one of independent contractor. I warrant that I will be responsible for any government employment tax/insurance/immigration obligations that may be necessary.
4. In consideration of your entering into this agreement and as compensation for the services to be rendered by you hereunder. I agree to pay you an amount equal to fifteen (15%) percent of any and all gross monies or other consideration which I receive as a result of agreements (and any renewals or renegotiations thereof) relating to my assignments throughout the world, which agreements are entered into through you during the term hereof. It is understood that substitution and replacement do not extend to include the shooting of material for a new campaign. In addition, I agree to pay you an amount equal to ten (10%) percent of

any and all gross monies derived from any television commercials, industrials, usages and or renewal fees as the terms apply to "TV." I agree to pay or reimburse you for all out-of-pocket expenses, which you incur from time to time on my behalf.

5. The term of this agreement shall be for a period of two (2) years commencing as of this date, and it will be automatically renewed for (2) years at a time unless you or I give notice to the other of the intention to terminate.
6. This agreement shall be governed by and construed in accordance with the laws of the State of Florida applicable to agreements wholly made therein, and any dispute arising out of this agreement shall be resolved in the courts of the State of Florida.
7. I agree that I will not conduct business with or enter into any agreements with the contracted CMG client, independent of working through CMG.
